

# 'CITISSIMUM ALTISSIMUM FORTISSIMUM' CONTEST

# **RULES**

# 1. Organization

The organizer of this promotion is the Centre d'Arts Santa Mònica, aiming to conduct an online contest among its community of followers via the mobile social network Instagram, open to all individuals meeting the conditions outlined in these rules.

### 2. Participants

Participation is open to individuals over 18 years old with a public Instagram account who meet the following requirements:

- Follow @centredartssantamonica.
- · Like the giveaway post.
- Leave a comment answering the giveaway question and tagging three different people.

Participants may enter multiple times, provided they mention different profiles in each comment.

#### 3. Mechanics and Prizes

- The contest will be active from June 3 to June 15, 2025, until 11:59 PM.
- Only comments made within this period will be considered.
- On June 16, 2025, a draw will be held among all valid entries, selecting 8 winners.
- Winners will be announced on Instagram and contacted via direct message.
- If a winner cannot be contacted within 48 hours, a new winner will be selected.
- The prize consists of a pack including a t-shirt and cap from the exhibition. It cannot be exchanged for its monetary value.
- The prize must be collected in person at the center, and a photograph will be taken for sharing on social media.

#### 4. General Conditions

- Offensive, discriminatory comments or those violating third-party rights are not permitted and will be disqualified.
- The Centre d'Arts Santa Mònica reserves the right to remove any comment deemed inappropriate.
- Participants agree to Instagram's terms of use: instagram.com/legal/terms
- By participating, contestants authorize the center to capture their image, as established in section 3, and grant image rights of the photographs taken for dissemination within the framework of the CITISSIMUM ALTISSIMUM FORTISSIMUM exhibition contest on the center's official channels.
- Participation implies full acceptance of these rules and the interpretative decisions of the Centre d'Arts Santa Mònica.
