

# 'CITISSIMUM ALTISSIMUM FORTISSIMUM' CONTEST

## RULES

### 1. Organization

The organizer of this promotion is the Centre d'Arts Santa Mònica, whose purpose is to hold a contest among visitors of the exhibition CITISSIMUM ALTISSIMUM FORTISSIMUM. All individuals who meet the conditions set out in these rules may participate.

### 2. Participants

All individuals over 18 years of age who visit the exhibition and fill in the participation form with the following information may enter::

- Full name
- Email address
- Acceptance of the contest rules and data protection
- Signature

Only one entry per person and email address will be accepted.

### 3. Mechanics and Prizes

- The contest will run from June 27 to July 6, 2025, at 8:30 p.m., during the center's opening hours.
- Participants must fill in the form and place it in the designated box at the reception of the center.
- Only forms submitted within this period will be considered.
- On July 8, 2025, a draw will be held among all valid entries, and two winners will be selected.
- Winners will be contacted via email.
- If a winner cannot be contacted within 48 hours, a new winner will be selected.
- The prize consists of a pack with a t-shirt and cap from the exhibition. It cannot be exchanged for cash.
- The prize must be collected in person at the center, and a photo will be taken to be shared on social media.

### 4. General Conditions

- Offensive, discriminatory, or rights-violating comments will not be accepted and will be disqualified.
- The Centre d'Arts Santa Mònica reserves the right to discard any form that does not contain the required information listed in section 2.

- By participating, contestants authorize the center to capture their image, as outlined in section 3, and transfer image rights of the photographs taken for dissemination in the context of the CITISSIMUM ALTISSIMUM FORTISSIMUM exhibition contest through the center's official channels.
- Participation implies full acceptance of these rules and the interpretative decisions of the Centre d'Arts Santa Mònica.

## PERSONAL DATA PROTECTION
